


TO-220F-3 Internal Structure of MBR20150C






Figure 1. Typical Forward Voltage Per Diode




Figure 3. Average Rectified Forward Current vs. Case Temperature (Square, Per Diode)





Figure 2. Typical Reverse Current Per Diode


