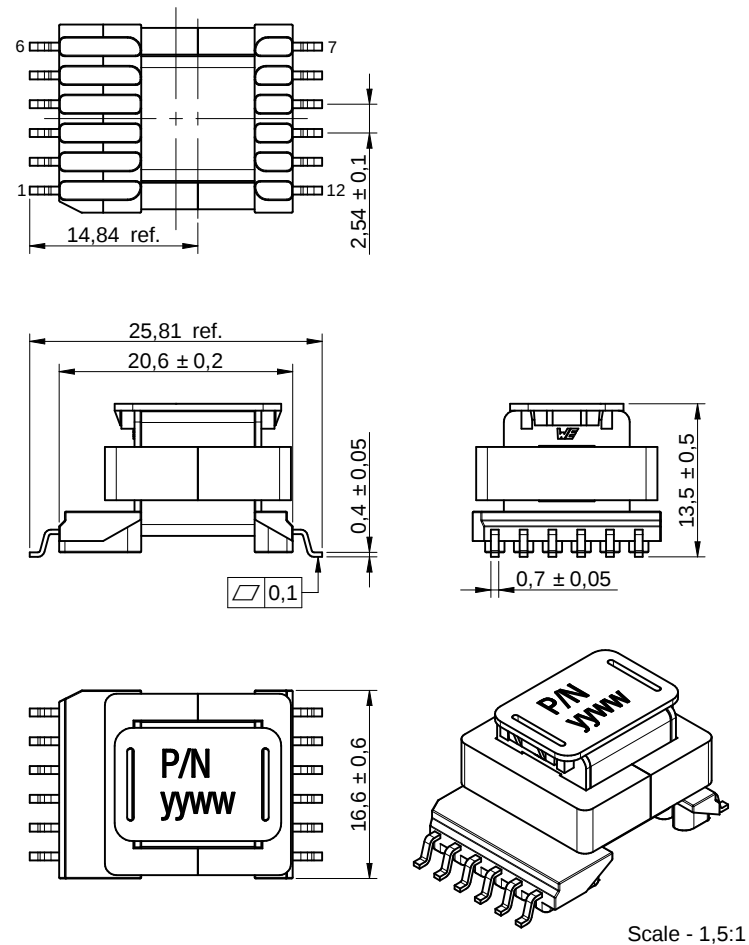
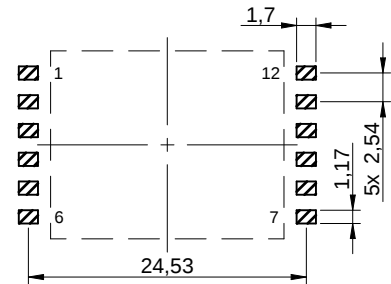

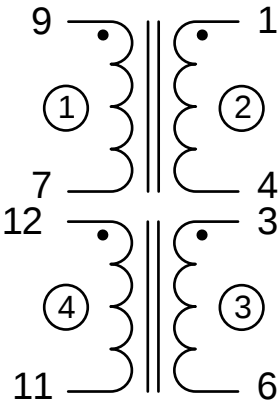


Recommended Land Pattern: [mm]

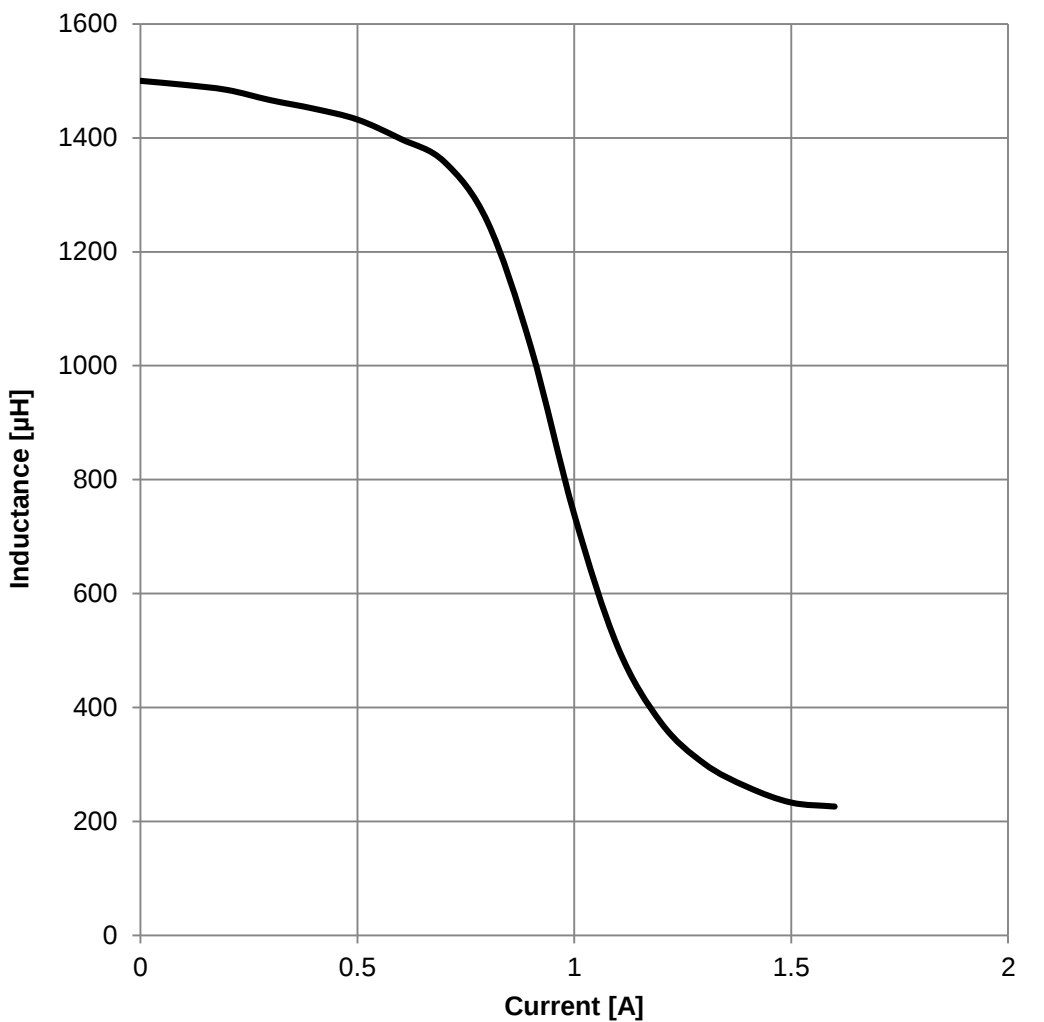

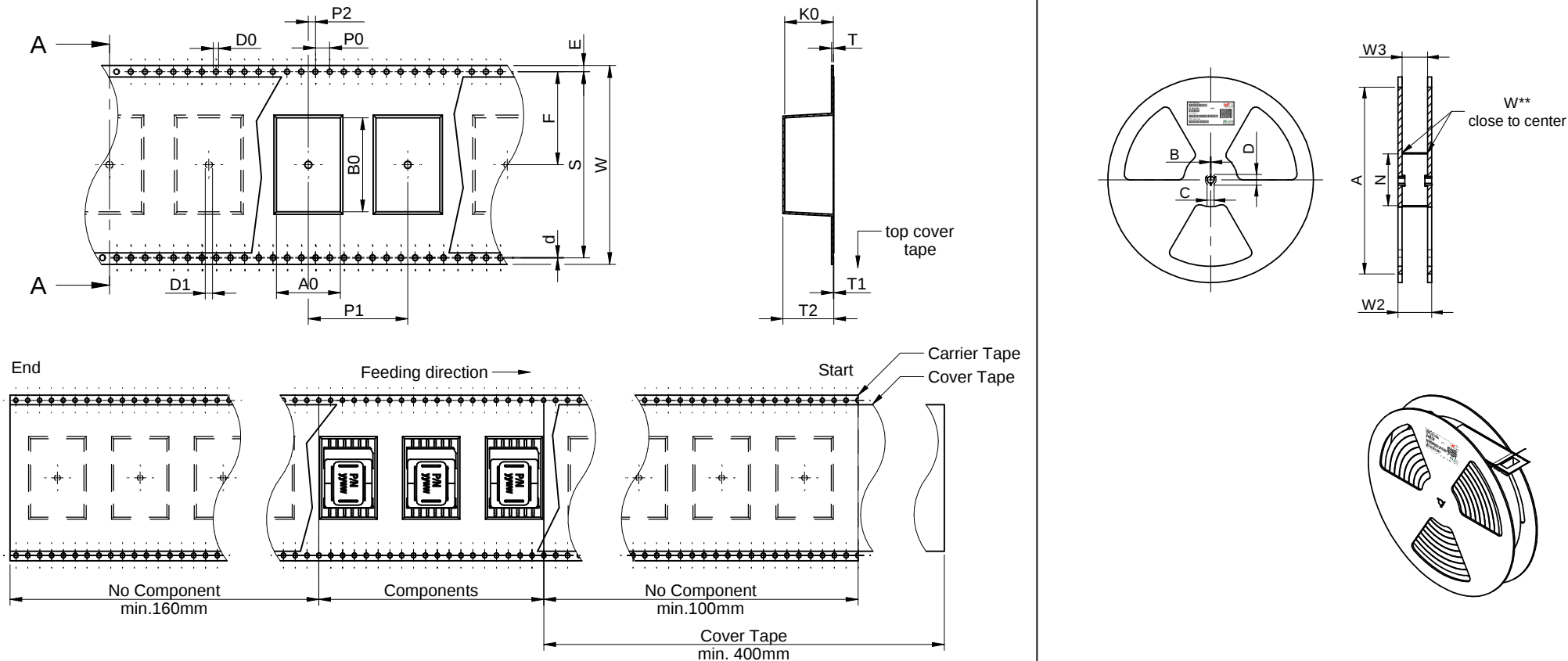
Typical Inductance vs. Current Characteristics:

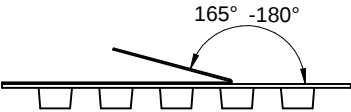
