



F1 Typical Inductance vs. Current Characteristics:




F2 Typical Temperature Rise vs. Current Characteristics:

F3 Typical Impedance Characteristics:



- Violation of the technical product specifications such as exceeding the nominal rated current will void the warranty.
- •Solvents may influence the product marking.
