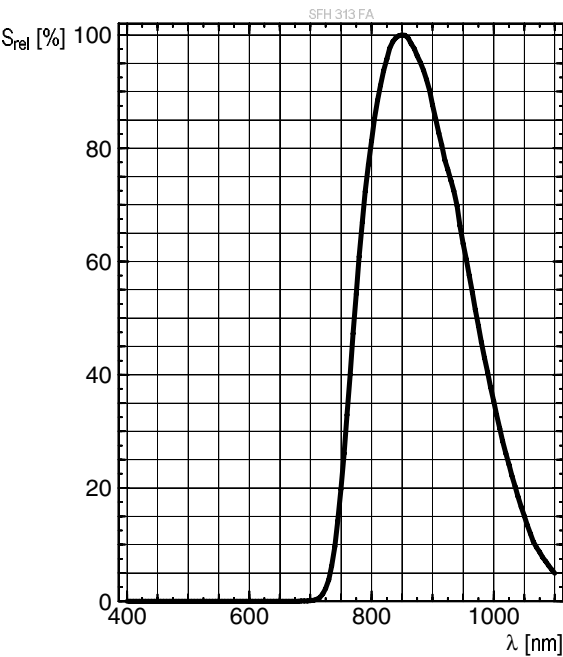

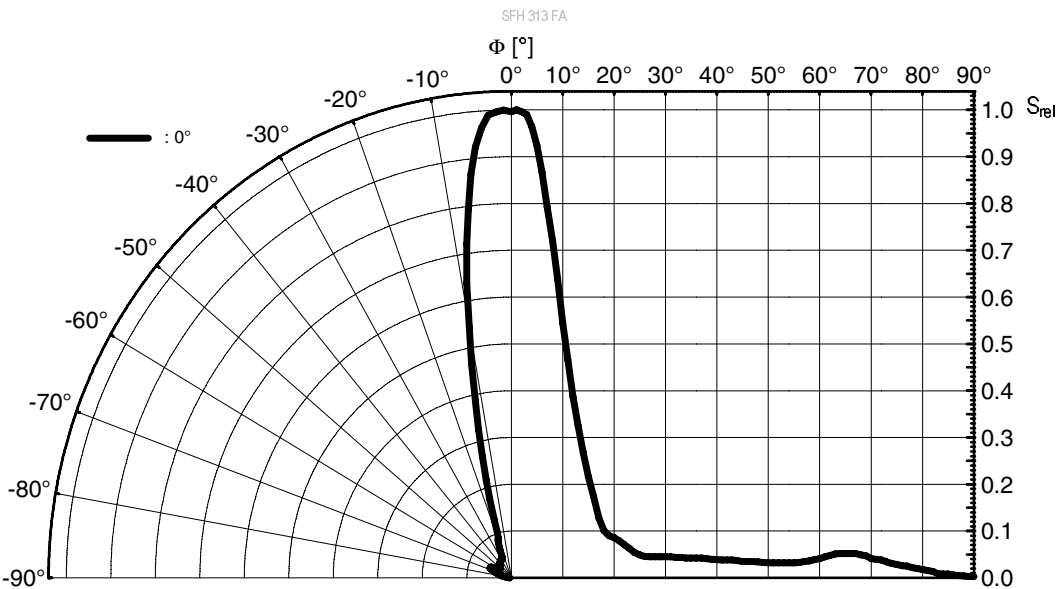
Relative Spectral Sensitivity 4), 5)

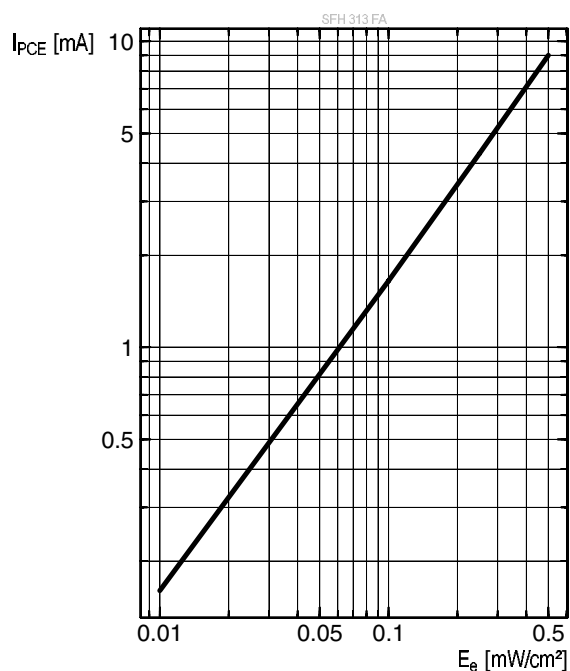

$S_{rel} = f(\varphi)$

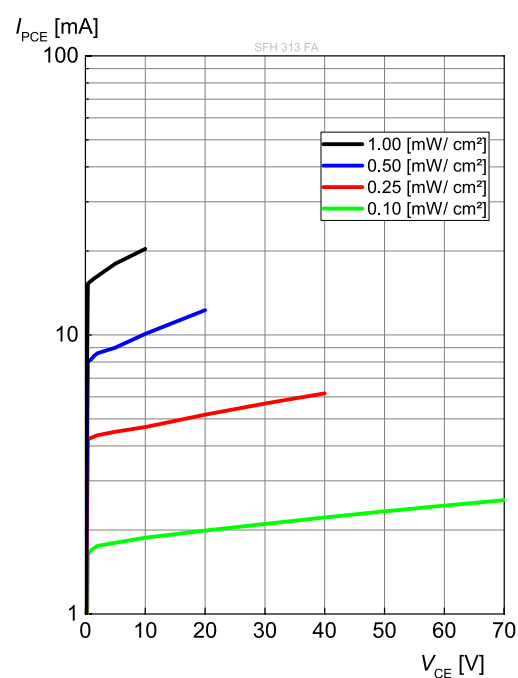

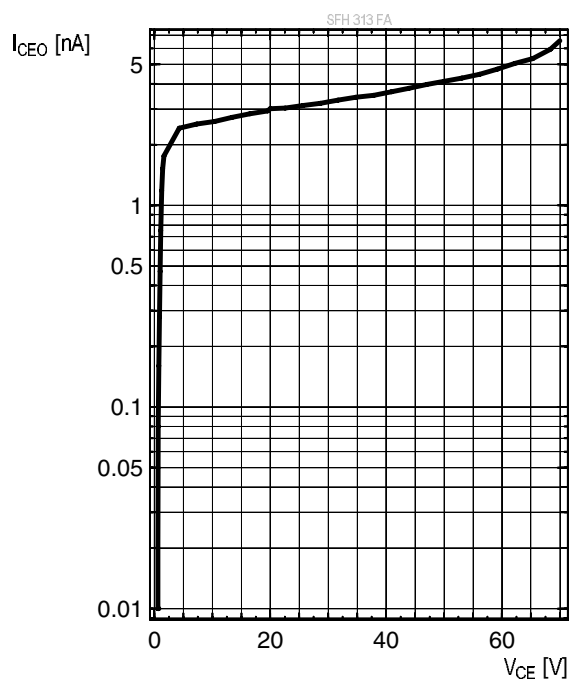

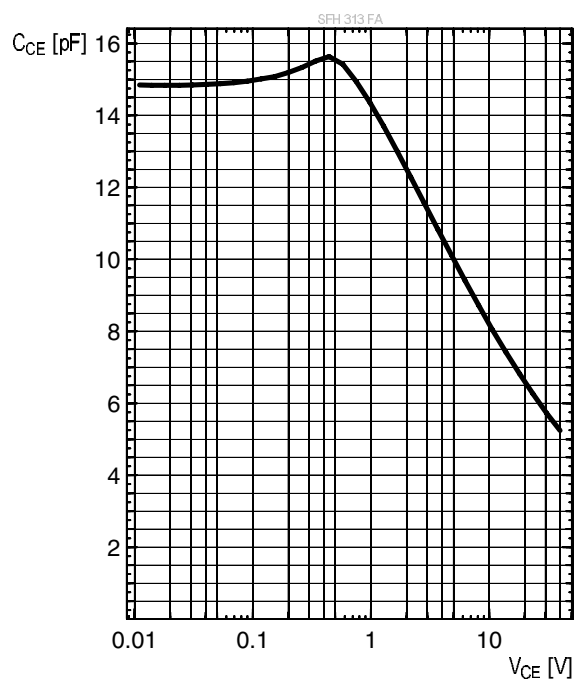

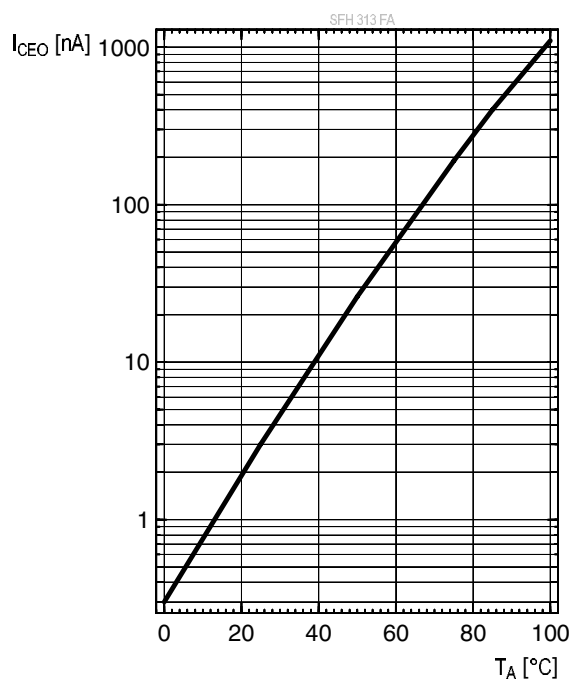
Collector-Emitter Capacitance ^{4), 5)}

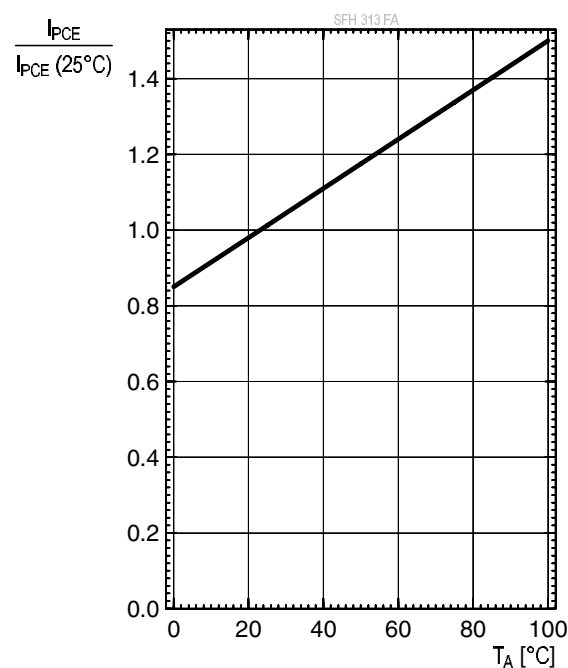
Dark Current ⁴⁾

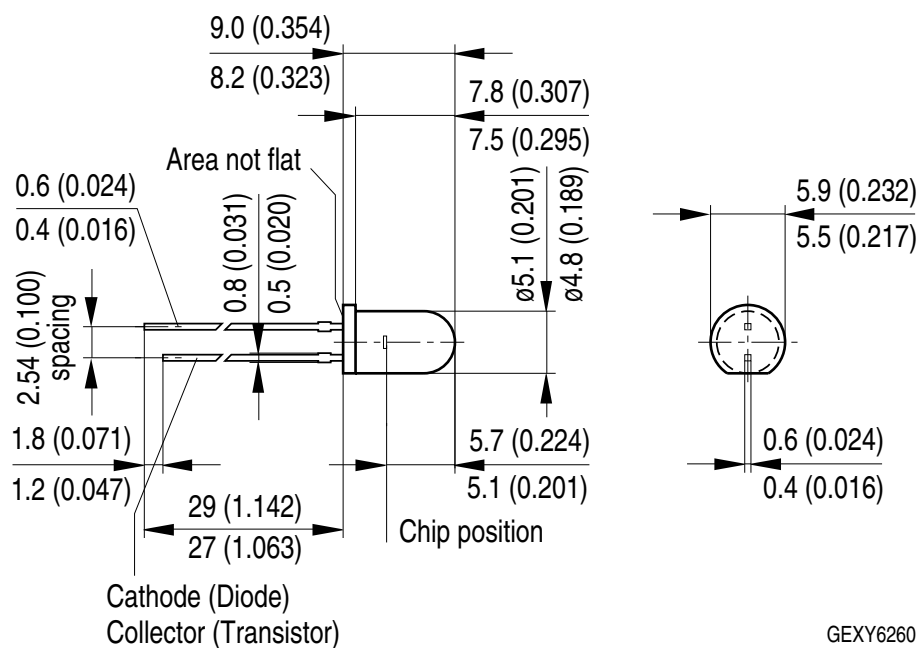


Photocurrent ⁴⁾

Dimensional Drawing ⁶⁾

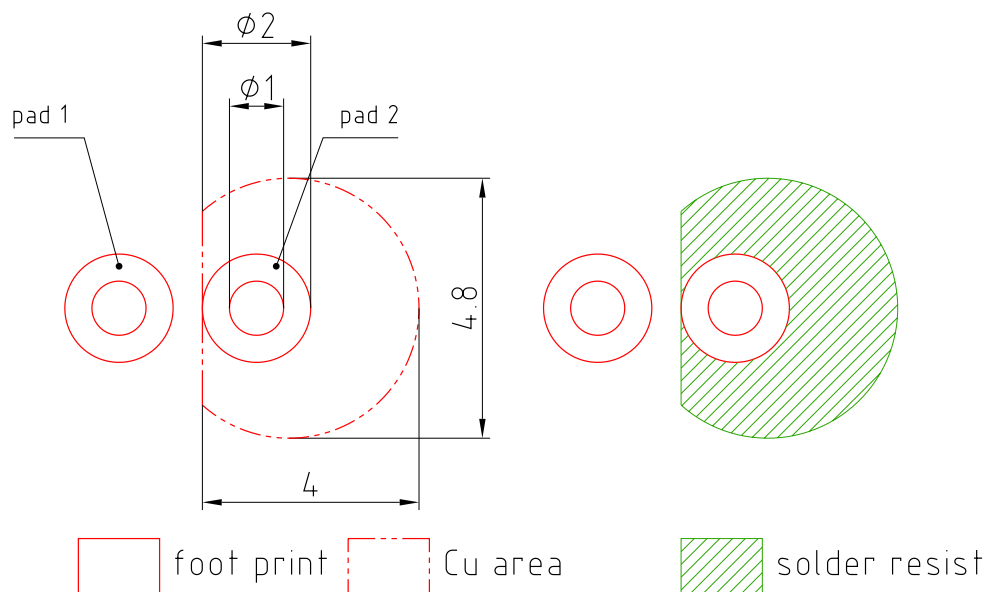

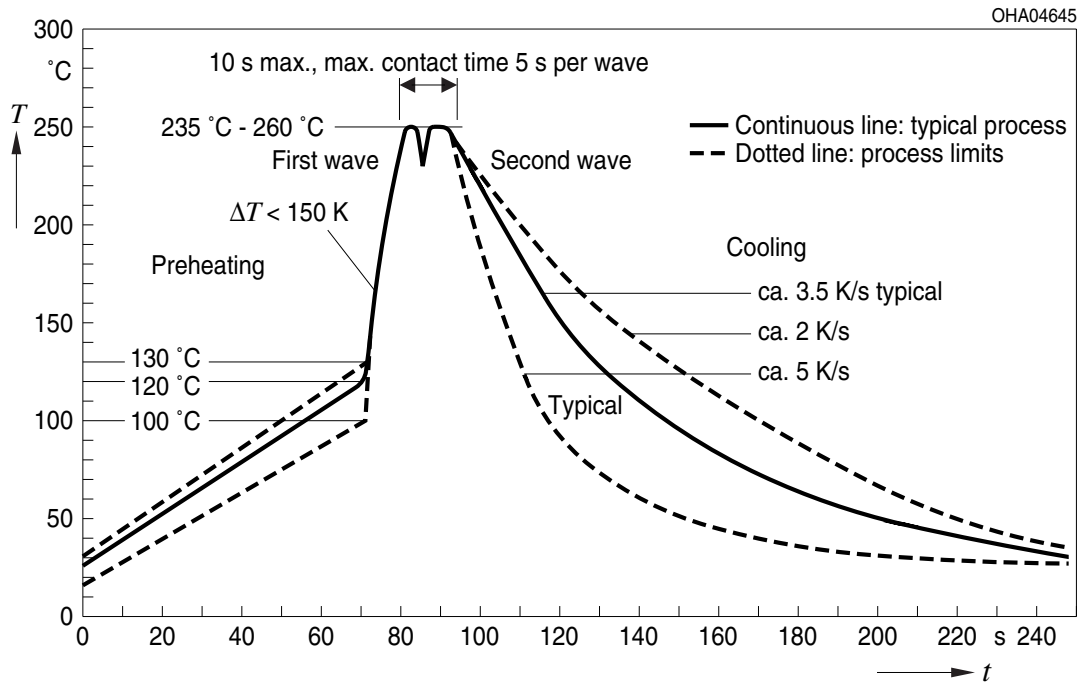
