1. General description

The 74LVC08A-Q100 provides four 2-input AND gates.

Inputs can be driven from either 3.3~V or 5~V devices. This feature allows the use of these devices as translators in mixed 3.3~V and 5~V applications.

This product has been qualified to the Automotive Electronics Council (AEC) standard Q100 (Grade 1) and is suitable for use in automotive applications.









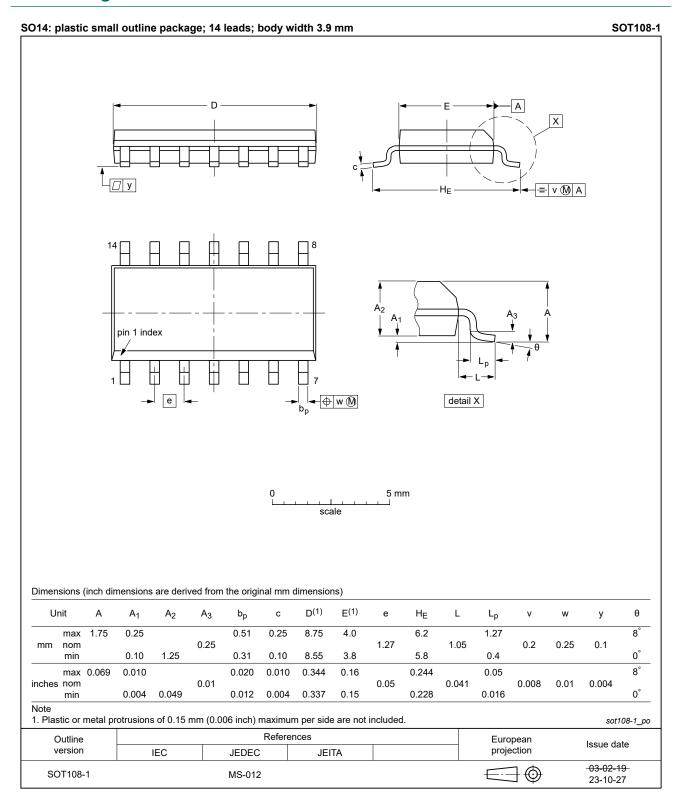


Fig. 6. Package outline SOT108-1 (SO14)




Fig. 7. Package outline SOT402-1 (TSSOP14)




Fig. 8. Package outline SOT762-1 (DHVQFN14)
